### **Healthy Mothers and Babies Programs:**


**Healthy Start:** St. Louis Healthy Start is a federally funded initiative to reduce racial disparity in infant death by promoting prenatal care and coordinating system level changes. In 2009 this program was renewed for another five bringing the total federal funds leveraged by MCFHC to over \$7 million which have expanded services reduce infant mortality in high risk neighborhoods.

**Fetal Infant Mortality Review (FIMR):** FIMR identifies and addresses the risk factors that lead to infant deaths and gaps in the systems of care that could prevent future deaths.

**Prenatal and Infant Wellness Collaborative:** This partnership reduces infant death and low birth weight births by increasing early and regular prenatal care. The Collaborative is developing and piloting a coordinated, comprehensive outreach and education campaign in the 27<sup>th</sup> Ward of the City of St. Louis. A Maternal and Infant Health Summit attended by 62 health and social service providers was held in 2010 to increase understanding of racial, ethnic and socio-economic disparities in infant mortality and the barriers to early and regular prenatal care.



## Healthy Families and Communities Programs:



**Gateway Immunization Coalition (IC):** This partnership protects children, adolescents and adults against vaccine preventable diseases and provides updated immunization information to health care professionals. The Coalition is proud to help provide more than 100,000 immunizations to area residents through its partners. Special emphasis was placed on educating teens and their parents about changes in vaccine recommendations. The Flu Task Force coordinates flu vaccine promotion and education and operates a flu information line every year.



**Mapping a Course:** The Mapping a Course initiative advanced in 2010 with the completion of an action agenda and release of the agenda in December. The MCFHC coordinated planning groups focused on maternal mental health, access to health insurance and healthy homes.

**State of MCH Forum** - The MCFHC convened over 50 stakeholders to a forum informing stakeholders about the impact of health reform on the women and children.



# 2010 Financial Snapshot


## **FY 2010 Revenue Sources**
