State Representative of District 87, Ian Mackey received an overall High Impact level. That means that on several issues he was the champion of a cause. He holds office hours/town halls, sits on committees or boards of organizations that are working on addressing these issues, and utilizes all his platforms to elevate these issues. However, he is not quite a champion for all these issues yet. This report shows the breakdown of the policies he was a real champion for, as well as those areas in which he could do better.

- Prioritize Black moms and babies in budgets.
- Partner with elected officials who are champions of this issue and support their work.
