State Representative of District 77, Steven Roberts received an overall High Impact level. That means that on several issues he was the champion of a cause. He holds office hours/town halls, sits on committees or boards of organizations that are working on addressing these issues, and utilizes all his platforms to elevate this issue. This report shows the breakdown of the policies he was a real champion for, as well as those areas in which he could do better.

Recommendations for Improvement:

- Speak with and listen to Community Health Workers and Home Visitors and act on what they say is important.
- Attend trainings and events focused on racial equity.
- Partner with expert organizations to learn more about these calls to action and elevate their expertise.

I. Social Determinants of Health: 83 out of a possible 94 points

Steven Roberts had a High impact level when it came to Social Determinants of Health. Representative Roberts participated in a voter-approved initiative process that successfully passed. It calls for gradual increases of the federal minimum wage from \$8.60/hr (Dec. 2019) to \$12/hr (2023). The following table lists the policies that Steven Roberts rated himself on.
